2. Please provide a brief description of what you are screening

The Social Housing (Regulation) Act regulations came into force on April 1st 2024. The new regulations and inspection regime require social housing landlords to deliver in line with the four consumer standards relating to Quality and Safety, Transparency Influence and Accountability, Neighbourhood and Community and Tenancy. Social housing is governed by a range of legislation and these new consumer standards build upon the existing legislative requirements. This report is

an update on the work taking place across Housing to make sure we meet the regulations. The new regulations require social housing providers to report a range of performance measures on an annual basis. The first of these is the Tenant Satisfaction Measures which will be reported to the Regulator in June 2025 for the second time covering the year April 1st, 2024, to March 31st 2025. This report gives Cabinet an update on the work being done to make sure Housing meets the new regulatory standards, including the new revised consumer standards.

3. Relevance to equality and diversity

The consumer standards are focussed on the quality of delivery for tenants and there is an expectation that landlords will know their tenants and will adapt delivery to meet particular needs, including in response to those with protected characteristics. In effect, being inclusive and respecting and responding to diversity and aiming for equality of access are core tenets of the new regulations. The new regulatory framework for social housing will include inspections so landlords will be judged on how well they are meeting these requirements.

The consumer standards that came into force from April 1st 2024 had a period of public consultation before being finalised. The final Equality Impact Assessment was published alongside the finalised consumer standards on February 29th 2024, and can be found at:

Given that this is a six-monthly update to Cabinet, it has been determined that there is no equality implications from this report.

The Government's Equality Impact Assessment has been considered when reviewing the Tenant Satisfaction Measures to make sure we are compliant with the new regulations.

As the government's assessment states, equality considerations were taken into account throughout the development of the new consumer standards. The work being done by the Housing service puts all groups of tenants at the heart of what we do but understanding that we need to evidence that services are accessible to and offered in ways that meet the needs of those with protected characteristics.

Overall, the new regulations require housing providers to evidence that they know the make-up of their tenant base and are adjusting the delivery of services to meet the needs of particular groups and those with protected characteristics.

The Housing Service collect all protected characteristic information at the point of joining the housing register for prospective tenants and as part of the tenancy health check for existing tenants. The collection of this information has been mandatory within the Housing Management System.

To ensure compliance with the new regulations Housing will be looking to report on the makeup of the tenant base in relation to protected characteristics and acting upon any issues identified. This will be part of the future updates to Cabinet on the social housing reforms.

Implementing the provisions of the regulations build on existing Council policies and practices that have themselves have already been subject to an Equality Impact Assessment.
